Community List fees[^]	No fees are payable in respect of Tribunal proceedings under the <ul style="list-style-type: none"> ➤ <i>Advance Care Directives Act 2013</i> ➤ <i>Consent to Medical Treatment and Palliative Care Act 1995</i> ➤ <i>Guardianship and Administration Act 1993</i> ➤ <i>Mental Health Act 2009</i> other than a request for provision of a transcript or an application for an internal review of a decision where the applicant is not a person who is the subject of the proceedings
Concessions	The Concession Fee is 25% or ¼ reduction for level 1 and land valuation fees, or 75% or ¾ reduction for level 2 fees rounded down to the nearest whole dollar
Prescribed Corporations	* A prescribed corporation does not include a not-for-profit organisation, or a small business (that has less than 20 full-time equivalent employees and is not subsidiary of a corporation that has 20 or more full-time employees).
